2. The Member shall be solely responsible for ensuring compliance with the requirements prescribed under applicable law(s) in relation to its business operations being carried out from the Premises. 3. The use of the Premises for the limited purpose of using the office space and obtaining the statutory registration(s)/ license(s)/ permit(s) does not entitle the Member to claim any rights of possession, tenancy, easement, deemed tenancy, license or any similar right of similar nature.
4. On expiry or termination of the Agreement, the Member shall immediately remove himself from the Premises and ensure to get cancelled/ remove all registration(s)/ license(s)/ permit(s) etc. filed with statutory/ government authority(ies) and shall submit written relevant proofs of the same to WeWork.
5. The Member shall indemnify, defend and hold WeWork harmless from and against any and all claims, damages, losses, liabilities, expenses including reasonable attorneys’ fee arising out of or as a result of usage of Premises by the Member for statutory registrations or breach and non-compliance of applicable laws.
